The best results with this product are obtained when it is applied to actively growing grass, and watered into the turf soon after application. Avoid mowing immediately following application to prevent pick-up.

For best results, sweep or blow the fertilizer off walks and painted surfaces following application to avoid discoloration.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk, or street back onto your lawn.

Recommended applications are at the rate of 1.0 lbs of nitrogen per 1,000 sq ft. Actual rates and timing of applications will vary with weather, soil and turf conditions.
