Application	Rate
Greens and Tees	Apply 2 to 5 ounces of LESCO 12-0-0 Chelated Iron Plus in sufficient water for thorough coverage (usually 3 -5 gallons per 1,000 sq. ft.)
Fairways, Lawns, Athletic Fields and Other	Apply 2 to 3 gallons per acre of LESCO 12-0-0 Chelated Iron Plus in sufficient water for thorough coverage or approximately 130 - 218 gallons per acre. Apply 6 to 9 ounces in 3-5 gallons of water per 1,000 sq. ft. to smaller areas.
Ornamental:	Foliar - Mix 1 gallon of LESCO 12-0-0 Chelated Iron Plus in 100 gallons of water and spray foliage to the point of runoff. For best results apply to actively growing foliage. For optimal results avoid watering for 24 hours.
Soil Application	Mix 3 to 5 gallons of LESCO 12-0-0 Chelated Iron Plus in 100 gallons of water and inject within the drip line approximately 1 to 2 gallons of finished solution.
