**DIRECTIONS FOR USE:** This LESCO product is a professional nursery grade fertilizer and should be applied to plants and landscape beds.

For best results, application rates should be used as a guide. Prior grower experience and judgement should be used before applying any fertilizer.

Apply LESCO Professional Nursery Fertilizer at a rate of 12.5 to 20 pounds of 1,000 sq ft (50' x 20') to flower beds and planting areas. Use a LESCO rotary, chest spreader or hand application method to apply the fertilizer. Apply twice per year or as needed to maintain plant vigor. For new plantings, the fertilizer may be incorporated into the soil prior to planting or top of the soil around plants after planting.
