Product Description:

LESCO 30-0-0 is a controlled released nitrogen that is engineered on four unique release characteristics to obtain constant growth pattern of the plants. LESCO 30-0-0 releases the proper amount of nitrogen to the plant to avoid nitrate losses from the soil. This product utilizes the microorganisms in the soil to release the nitrogen at the proper rate for the plants. There are minimum losses of NO3 and NH3 from the soil, which reduces the total nitrogen needs for the crop without sacrificing performance, yield and health of the plant.

Mixling Instructions:

LESCO 30-0-0 can be mixed with water, fungicides, insecticides, herbicides, surfactants and other liquid fertilizers. If using EC pesticides with LESCO 30-0-0, make sure all EC mixtures are added to the spray tank last, after all other products in the mixture has been fully mixed and agitated in the tank.

When using LESCO 30-0-0 through an irrigation system, follow the use rates for the nitrogen at the label rates as desired. Set the irrigation system properly to allow the correct rate to be applied to the crop. LESCO 30-0-0 is non-burning so foliar contact will not harm the plants. Other fertilizer or chemicals mixed with LESCO 30-0-0 may cause damage to the crop. Follow each label before making the application to the crop.
