### DIRECTIONS FOR USE:

**Fairways, Lawns, Athletic Fields, and other Turf Areas** - apply 0.5 - 2 ounces/1,000 sq ft in sufficient water for thorough coverage (usually 1-5 gallons per 1,000 sq ft). Three to four applications per growing season are recommended to maintain vigorous turf. Avoid watering for 24 hours after application for optimal results. Application to turfgrass areas by injection into the irrigation system will provide good dilution and distribution. Observe all local regulations while connecting injectors to an irrigation system to avoid contamination of potable water. In Virginia, this lawn fertilizer, which contains phosphorous, is intended only for nonagricultural use on (i) turf during its first growing season, (ii) turf areas being repaired or renovated, and (iii) turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not intended for the routine maintenance of turf.

**Trees & Ornamentals** - for foliar and drench applications, mix 1 - 4 pints in 100 gallons of water and spray or drench to the point of runoff. Best results will occur when the product is applied to actively growing foliage during periods of high humidity and low plant stress. Early morning, late afternoon, or cloudy days are preferable to hot, dry conditions. Avoid watering for 24 hours after application for optimal results.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands on the driveway, sidewalk or street back onto your lawn.
