Golf, Residential Lawns, Athletic Fields, and other Turf Areas - apply 0.5 - 2 ounces/1,000 sq ft in sufficient water for thorough coverage (usually 1-5 gallons per 1,000 sq ft) Three to four applications per growing season are recommended to maintain vigorous turf.

According to state law in Maryland, this product may not be applied at an application rate of more than 0.7 lbs. Nitrogen per 1,000 sq. ft.

Application to turfgrass areas by injection into the irrigation system will provide good dilution and distribution. Observe all local regulations while connecting injectors to an irrigation system to avoid contamination of potable water.
