### **ENVIRONMENTAL HAZARDS**

This product has low solubility in water. At the limits of solubility, this product is not toxic to fish. However, at concentrations above the level of water solubility, it may be toxic to fish. This product controls susceptible weeds by inhibiting weed seed germination and root development. Most effective weed control will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation prior to weed seed germination and within 14 days following application.

- Not for use on plants being grown (1) for sale or other commercial use, (2) for commercial seed production, or (3) for research purposes. For use on plants intended for aesthetic purposes or climatic modification and being grown in ornamental gardens or parks, or on golf courses or lawns and grounds.


Apply uniformly through suitable, calibrated commercial application equipment.

### ESTABLISHED TURF

This product is a selective pre-emergence herbicide that, when properly applied, will control certain grass and broadleaf weeds in established turf grass and lawns. The maximum amount of this product that may be applied per year is given for each turf grass species in the **Maximum Annual Rates** section of this label.

Most effective weed control in turf grasses will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation prior to weed seed germination and within 14 days following application. See the information below for approximate crabgrass seed germination dates.

### RATES OF APPLICATION

This product may be applied as a single application or in sequential applications to control weeds germinating throughout the year. All applications must be made prior to germination of the target weeds. This product will not control established weeds. Maximum use rate selection should be based on turf species. The length of time of residual weed control provided by this product is related to the rate applied.

### ESTABLISHED LANDSCAPE ORNAMENTALS

This product may be applied to established ornamentals as a broadcast, over the top, or directed application. Irrigation or rainfall soon after application will wash residues off plant foliage and activate it into the soil

### **Newly Transplanted Landscape Ornamentals**

This product may be applied to newly transplanted ornamentals as a broadcast, over the top, or directed application. Delay application to allow soil to settle around new transplants and water thoroughly before applying this product. Apply after cuttings form roots and become established. Apply before budding/grafting or after buds/grafts have taken to avoid any inhibition of the tissue union.

### **Tolerant Ornamental Species**

This product will not harm most trees, shrubs, vines and flowers. The species listed below are tolerant to this product. Best results will be obtained when it is uniformly applied to the soil surface; avoid applying to ornamental shoots which may defeat the effort to get uniform distribution on the soil surface. This product may be applied over the top of these species. When plants are under stress (such as heat, drought or frost damage) some cultivars of listed plants may be sensitive to this product.
