The universal "T" tip design sprays crisp lines suitable for most interior and exterior line marking applications.

#### Directions for Use:

1. Can temperature must be between 55-85°F.
2. **Note: high solids.** Shake the can vigorously for a full 30 seconds AFTER you hear the ball start to rattle.
3. Install and align can correctly in striper (if using).  
Adjust can height for desired paint stripe width.
4. Activate spraying by pressing trigger.
5. Partial cans can be saved for later use.  
Before saving can, clean spray tip by holding can upright and pointing it away from your face and body. Depress tip to one side for a few seconds until propellant is sprayed and tip is cleared of residue.
6. Before reusing any saved aerosol cans, make sure to shake can until ball rattles for at least 30 seconds.
