#### LAWN AND PERIMETER APPLICATIONS

**Perimeter Application:** Apply 3.33 to 6.66 pounds per 1000 sq. ft. to lawn areas 6 to 10 feet wide around and adjacent to the structure.

Lawn Application: Apply LESCO CrossCheck 0.069% Plus Fertilizer with suitable broadcast application equipment to ensure uniform coverage over the treatment area. Apply 3.33 to 6.66 pounds per 1,000 sq. ft. to control the following pests:
