Unsuitable Extinguishing Media: Do not use water jet. Use of heavy stream of water may spread fire.

5.2. Special Hazards Arising From the Substance or Mixture

Fire Hazard: Not considered flammable but will burn at high temperatures. Decomposes above 132 °C (270 °F). Under conditions of fire this material may produce: Ammonia. Nitrogen oxides. Biuret.

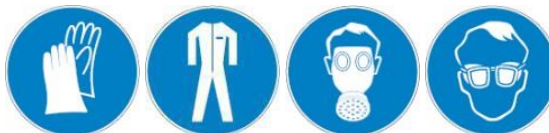

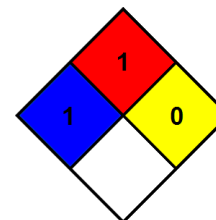
