DIRECTIONS FOR USE

This product is a fertilizer suitable for use in any given application depending upon existing soil chemistry, turf type, and intended use of the turf area. The best results with this product are obtained when it is applied to actively growing grass, and watered into the turf soon after application. This product is compatible with most liquid fertilizer/pesticide mixes at manufacturers' specified label rates. It is recommended that a "jar test" be performed prior to actual mixing large quantities to insure compatibility.

For Trees/Shrubs: Add 3 gallons of 18-03-06 per 100 gallons of solution. Soil inject on a grid pattern for even distribution. Inject 1 gallon of solution per diameter inch at breast height for trees and .25 gallons of solution per foot of shrub height.

NOTE: Use in accordance with recommendations of a qualified individual or institution, such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan.
